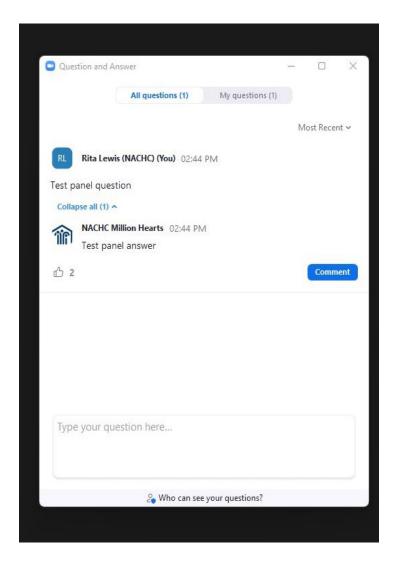

## Success With Lipids

USE OF A POC LIPID MACHINE TO IMPROVE STATIN USE & CV OUTCOMES

### Initial Plan

UDS High-Risk Statin Groups (per CMS 347):

- 1. LDL >/= 190
- 2. DM age 40-75 with LDL 70-189
- 3. Age 21+ with diagnosis of ASCVD

### Plus Any Scheduled Clinic Visit

Check BPA each morning during scrub (should capture all CMS UDS groups + ASCVD >/= 20%).

MA place "High Risk Lipid" on appointment desk for matching patients

In visit: Perform POC testing if no lipid < 12 months

Trigger provider discussion re: high intensity statin using dot phrase as guide.

### POC Machine Set Up





### Results

Increased number of patients receiving statin therapy

Great opportunity to leverage Team Based Care to help address hesitancy toward therapy.

Added a Piccolo machine to expand to CMP

Increased follow up and screening thanks to ease of POC

### **Identify Patients Who Need Statins**

#### Lab results

- -LDL > 190
- DM2
- ->7.5% ASCVD

Telephone encounter sent to front desk






### Set blocks during the week

- Able to better track pts
- Not all that are scheduled will answer phone
- Reschedule when possible



### **Virtual Visit Workflow**







- Discuss all lab results with focus on lipids
- Risks vs Benefits of statins
- Discuss role of statin and risk reduction
- Address patient's questions/hesitations
- Empathy and understanding





- Patients may not pick up phone
- Technology issues
- Connection issues
- Hesitancy about taking a statin





- Allows provider to have enough time for discussion with patient
- Convenient for patient, no need to come into office
- 1 on 1 discussion seems to be more effective than sending a message via medical assistant
- All questions answered
- Taking time outside of normal office visits provides reassurance which can be effective towards daily compliance

Our statin prescribing rates improved by 10 points from 76% in Dec 2021 to 86% in July 2022
